

INDIVIDUAL REGISTRATION TERMS AND CONDITIONS

THE REGISTRATION FEE INCLUDES:

Registration Fees, Payment, and Invoicing

All registration fees are indicated in US Dollars (USD).

If you are from Argentina, payment will be taken in Argentine Pesos (ARS) at the official exchange rate on the day of payment.

The billing address can be set during the online registration process. It is not possible to modify billing details once the payment has been completed. Please ensure that the billing address and details are updated during the online registration process.

The indicated prices only apply if both the registration request and payment are received before midnight (GMT-3 Argentinian Time) on the corresponding registration deadline; otherwise, the higher registration fee will apply.

Registration Payment

Credit card payment (Visa, MasterCard, or American Express) can be securely made online. For payments in USD, PayPal will be used.

Bank transfers do not incur charges for the beneficiary. Payment via bank transfer is accepted until Friday, November 6. After Friday, November 6, any outstanding amounts must be paid by credit card or in cash on-site at the congress accreditation desk.

Registration Confirmation

Cancellation or Changes in Confirmed Registrations

Any cancellation or change to your registration must be made in writing to the congress organizers and is subject to the following conditions:

Cancellation by the Participant

- Cancellations made no later than Monday, October 12 will be refunded minus an administrative fee equivalent to 20%.
- Please note that if the registration fee is less than 150 USD, no refund will be issued.
- After Monday, October 12, no refunds will be issued.
- Refunds for cancelled registrations will be processed after the conclusion of the
 16th International Strabismological Association Meeting.

Name Changes/Substitutions

- Name changes are only possible for confirmed and paid registrations.
- After Monday, November 2, substitutions or name changes are subject to a 20
 USD administrative fee.

Double/Excess Payments

In the event of double payment or overpayment, an administrative fee of **10%** will be applied to the refund.
