Submission Instructions

To submit an abstract, please do register on this website. This does not involve any payment.

Abstract submission

Complete all the required sections of the abstract submission form. Failure to complete the required fields will result in an incomplete abstract. Incomplete abstracts cannot be reviewed. All submitted material must be written in English.

Completed submissions will be anonymously graded by the Scientific Committee. Name(s) of author(s) and statements of affiliation are not allowed in the title or abstract text.

Only one oral presentation will be selected from each presenting author, regardless of the number of abstracts submitted.

If you wish your selected presentation to be published in the Transactions of the ISA Congress 2026, please read the instructions provided in this web page.

The online abstract submission form will not work well with Firefox, Safari or older versions of Internet Explorer. For best results, use the most recent version of Chrome. You can download Chrome for free.

- Abstract submission opens on February 1st, 2026.
- Abstract submission closes on April 30th, 2026.
- Abstract admission communication to the speakers: June 30st ,2026.
- Deadline for presenters to register: August 15th, 2026.

Presentation Format

- Oral presentation
- Poster (hard copy).

All abstracts are reviewed as potential oral presentations or poster presentations with the Scientific Committee making the final decision. Submitting authors may wish to limit their abstract to oral presentation or poster only. If this option is selected and the author's preference cannot be met, the abstract will be rejected. Abstracts without specification have the best chance of being accepted.

Instructions for Oral Presentation

Oral presentations limited to 7 minutes, followed by 3 minutes for questions and discussion. Slides should be formatted in widescreen 16:9 using the Power Point page set-up function. Ensure that slides are easy to read by using large text and avoiding overcrowding with excessive information. Please verify that all videos run correctly and that all required files have been uploaded. Any potential conflicts of interest must be disclosed on a slide immediately after the title slide.

Instructions for Poster Presentation

Hard copy posters should be prepared in the specified size (1.70 x 0.85 meters) and vertically oriented. All posters will be displayed for the duration of the whole conference. Please mount your poster on Wednesday 11th and leave it on display until the end of the meeting. Any potential conflicts of interest should be clearly declared on the poster. If you have been invited to present your work orally in "The Best of ISA Posters at a glance", this will be in addition to displaying your hardcopy poster. Each presentation will last 3 minutes, followed by 2 minutes for questions or discussion.

For the abstract to be considered, at least the presenting author must be registered for the ISA 2026 before **August 15th, 2026.**

Abstracts limited to Poster will not be considered for an oral presentation.

The selection committee gives greater priority to work that is groundbreaking, that will impact practice patterns or has clinical implications.

1. Main Author
2. Main Author Affiliation (Institution/Company)
3. Co-authors
4. Co-author affiliation

6. Objective

8. Results

10. References (no more than three)

The maximum characters allowed for the main body of the abstract are 350 words (Objective, Material and Methods, Results, Conclusions). Longer abstracts will not be successfully submitted.

Reminders

- Did you proofread your abstract? Concise and clear abstracts are graded well. Misspellings and typographical errors reflect badly on the research.
- When using abbreviations within the abstract text, first include the complete term followed by the abbreviation in parenthesis. Example: Medial Rectus (MR).

Authors

- Changes to data provided in the abstract will not be allowed after the submission
- The Scientific Committee reserves the right to disqualify submissions that fail to meet the requirements.
- Submitting authors are required to provide contact information for all co-authors.

Other Information

- I verify that the abstract follows submission policy regarding copyright as described in the submission guidelines.
- I understand that submission of an abstract is an agreement to present as scheduled.
- All submitted abstracts must be original and authors must have the rights to present it.
